PRO-RATED DUES AMOUNT

If applying for membership between January 1 and April 30, pay only half the dues amount plus a non-refundable \$10 application fee.

If applying between May 1 and June 30, pay the full dues amount plus the \$10 application fee. Your membership will run through the end of the next fiscal year.
